Prohibition on sale of liquor under Section 54- in wake of ensuing General Elections to Haryana Vidhan Sabha-2019.

The Election Commission of India has announced the schedule of General Election for Vidhan Sabha-2019 for polling on 21.10.2019 and counting on 24.10.2019 in the State of Haryana. As per Commission's directions, a complete ban of sale of liquor is to be imposed before 48 hrs. from closing of the poll and the day of counting should also be declared as dry day. Hence, all liquor vends in District Rewari need to remain closed from 19.10.2019 to 21.10.2019 and on 24.10.2019 for smooth conduct of elections.

Now, in compliance of above said directions, I am satisfied that the on sale of liquor effective from 48 hours prior to closing of Polls is necessary to avoid annoyance, disturbance of public peace and tranquility in the District Rewari.

Now, therefore, in exercise of the powers vested in me by virtue of Section 54 of the Punjab Excise Act, 1914, I, Yashendra Singh, I.A.S., District Magistrate, Rewari hereby, order that all Liquor Vends/Bar/Pubs/Hotels/Aahatas and other maces shall remain closed for sale of liquor from 05:00 pm on 19.10.2019 to 21.10.2019 midnight and on 24.10.2019 in all the Assembly Constituencies of District Rewari.

This order shall be promulgated within the limits of District Rewari through wide publicity by Public Relation Officer, Rewari by means of local news-papers, by affixing copies of the order on the notice boards of the offices at Sub-Division, District and Tehsil level courts and other public places as well as the Police Stations. It shall also be hosted on the official website of the district www.rewari.gov.in prominently. Licensees and other concerned shall also be informed of this order in writing by the Deputy Excise & Taxation Commissioner, Rewari.
