Sub: Transportation of essential goods through Railway.

Ref: Order No.40-3/2020-DM-J (A) Dt.24.3.2020 issued by Ministry of Home Affairs, Govt.of India.

As per item 6(a) of order No.40-3/2020-DM-J (A) issued by Govt.of India, Ministry of Home Affairs, "Transportation for essential goods only" comes under exception of the purview of lockdown. Since Railway is engaged in movement of essential supplies, especially food grains on FCI account from the state of Haryana to the other parts of country, all railway stations enroute lying in the Haryana (even enroute Punjab) are required to be kept open round the clock.

2. Also, a numbers of Power Plants are located in the state of Haryana and Punjab for which coal is being transported from Eastern parts of the country. This movement is essential so as to provide uninterrupted power supply to citizens of Haryana.

3. Accordingly all Deputy Commissioners are hereby directed to ensure the Railway lines and other infrastructure open. Accordingly, all District Magistrates may inform the respective police heads in their jurisdiction.




