Subject: Advisory regarding exemption to Industries from lockdown promulgated in relation to COVID-19.

As requested by the Dept of Industries, following industries are exempted from Lockdown imposed subsequent to COVID 19 regulations. This is being issued to provide an indicative list of industries involved in essential services.

- i. Food, Food Products & other allied industries including transportation.
- ii. Milk, Milk Products & allied industries including transportation.
- iii. Agriculture, Vegetables, Fruits and Industries related to these packaging & procurement including transportation
- iv. Face Mask.
- v. Hand Sanitizer, Disinfectants, Alcohol and Bleach based.
- vi. Packaging Industries working for food and pharma industries. All Pharmaceuticals and Medical Industries. Poultry/Meat/Fishery Processing Unit.
- vii. Food Irradiation Unit etc
- viii. Cattle/Poultry feed/ Animal Feed manufacturing and transport. Industrial Units manufacturing water purifiers and purified water.
- ix. Industries manufacturing equipments/ materials used in public health services.
- x. Electricity generation, distribution and transmission.
- xi. IT services, IT Enabled services and Data Centers providing services to any essential industries.
- xii. Production transportation and supply chain, E-commerce of all essential goods
- xiii. including food, fast moving consumer goods, pharmaceutical, Sanitizer, Mask,
- xiv. Pest/Insect Control and Medical equipments, Warehousing of all essential food,
- xv. Grocery, Grains.

Factories/Production sites/Commercial Entities shall be allowed to have security and fire fighting personnel present at site.

The discretion whether a Continuous process, that cannot be stopped, is involved in the industrial unit under discussion, will vest with the District Magistrate. Similarly, if there is any doubt as to whether an establishment is

essential or not, the District Magistrate, shall be the competent authority to take the decision.
