
In continuation of this office letter no. 3/14-2Food-2019/13710-886 dated 07.09.2019, please find enclose herewith a copy of order bearing no. 3/14-1Food/2019/13677 dated 07.09.2019, on the subject cited above.

In exercise of the powers conferred by clause (a) of sub-section (2) of section 30 of the Food Safety and Standards Act, 2006 (Central Act 34 of 2006), Commissioner, Food and Drugs Administration Department, Haryana, Panchkula, had been prohibited in the interest of public health for a period of one year w.e.f. 07.09.2019, in the state of Haryana, to manufacture, storage, distribution/ or sale of tobacco which is either flavoured, scented or mixed with any of the said additives, and whether going by the name of form of Gutka, Panmasala, flavoured/scented tobacco, kharra, or otherwise by whatsoever name called, whether packaged or unpackaged and/or sold as one product, or through packaged as separate products, sold or distributed in such a manner so as to easily facilitate mixing by the consumer.

A copy of above mention order dated 07.09.2019, has already been sent to you vide this office letter no. 3/14-2Food-2019/13710-886 dated 07.09.2019, with requested to implement these orders in Haryana State and to take necessary action as per Food Safety and Standards Act, 2006, against the defaulting FBOs.

In view the spread of COVID-19 in Haryana State, you are again requested to implement the above referred orders dated 07.09.2019 strictly, in the public interest.




