Whereas WHO has declared the outbreak of COVID-19 as pandemic. There are more than 13,000 persons under surveillance in state of Haryana. It is necessary to take effective steps to prevent further spread of COVID-19.

Whereas COVID-19 transmits through droplets from mouth, sneezing, fomites there is possibility of transmitting of COVID-19 by use of Hookah and by common use of Hookah by many persons is further increasing the chances of spread of COVID-19.

Whereas under the law and in interest of Public Health at large and under Section 2 of Epidemic Disease Act 1897 and COVID Regulations 2020, Use of Hookah/water pipes in the state of Haryana is strictly prohibited to prevent spread of COVID19, Cigarettes & Other Tobacco product Act (COTPA), 2003 issued by Ministry of Law and Justice and Legislative Department on dated 19th May 2003 also be enforced with zero tolerance.
