
**Subject:- Implementation of Point Nos. 5 & 6 of National Directives for COVID-19 Management.**

Dear Madam / Sir,

Please refer to the National Directives for COVID-19 Management enclosed with the Ministry of Home Affairs order No.40-3/2020-DM-I(A), dated 15.04.2020 (copy enclosed). The directives at S.No. 5 and 6 for Public Spaces, mentioned in Annexure-I inter-alia provide for the following:

**5. Spitting in public spaces shall be punishable with fine.**

**6. There should be strict ban on sale of liquor, gutka, tobacco etc., and spitting should be strictly prohibited.**

2. In compliance with the above, you are requested to kindly issue appropriate directions to the ULBs to inform the citizens through a 'public notice' for observing of the above directives. Appropriate penalties may be imposed for violations, in order to make the urban areas, safe and healthier.

3. Copies of the public notices issued by the New Delhi Municipal Council and the MCDs are enclosed for reference.
