Whereas the MHA Government of India, vide its order No. 40-3/2020-DM-1(A) dated 01.05.2020 has extended the Lockdown for a further period of another 14 days w.e.f. 04th May, 2020 to 17th May, 2020, I, Yashendra Singh, District Magistrate, Rewari invoking the powers conferred under Section 144 Cr.P.C., do, hereby, prohibit the following in the interest of maintenance of public health, hygiene and safety in view of the COVID-19 pandemic:

1. Movement of any individual whatsoever for non-essential purposes shall henceforth remain restricted between 07:00 PM to 07:00 AM within in the district, as well as movement outward the district.
2. Persons above the age of 65, or having co-morbidities, suffering from chronic diseases, pregnant women and children below the age of 10 years shall not come out in open except in the case of a medical emergency or essential requirement as specified in the National Directives.
3. Gathering of 5 or more persons by organization/manager of all public places.



The compliance of this order shall be strictly enforced and ensured by all Executive Magistrates and Police Officials on duty and any violation of the same shall be strictly dealt with as per sections of 188, 269 and 270 of the Indian Penal Code, 1860.

The order shall be promulgated by uploading it on the District website, circulated it through Whatsapp groups and on other social/digital media, means of mass communication like radio, television may also be used and publicity vans of Public Relations Department be also deployed to disseminate the same.
