ORDER

This is in continuation of this office Order No. 757- 857/Disaster dated 22-05-2020. As per report of Sub Divisional Magistrate, Rewari vide letter No. COVID-19/RWR/1274 dated 22-05-2020, the Gud Bazaar, Rewari was closed till further orders. Now, the Sub Divisional Magistrate, Rewari has intimated vide letter no. Covid/RWR/1358 dated 25-05-2020 that the Executive Officer, Municipal Council, Rewari vide letter No. 1487/MCR dated 25-05-2020 has informed that all the shopkeepers of Gud Bazaar Rewari have formed circles for social distancing and a committee has been formed on behalf of the market to ensure that all the rules/instructions are followed by the market and that if the shopkeepers of Gud Bazaar, Rewari violate the rules/instruction he/she will be punished by the committee. The Gud Bazaar was inspected by the Executive Officer, Municipal Council, Rewari along with In-Charge, Bhadawas Gate, Police Chowki, Rewari and found that the shopkeepers were forming circles for social distance and the members of the association were present at the spot who assured that all the shopkeepers will fully follow the instruction given by the administration.

As per the report and recommendation of Sub Divisional Magistrate, Rewari, Gud Bazaar is allowed to reopen subject to the compliance of National Directives and this office order issued vide endst No. 17436-17536/ COVID dated 21-05-2020. Upon committing repeat violation, the shops/market shall be closed down for the entire remaining period of lockdown and action under Disaster Management Act. 2005 and Indian Penal Code shall be initiated against the delinquents.
