ORDER

The Civil Surgeon, Rewari has requested vide his office memo No. IDSP/RWR/958 dated 15-06-2020 that two residents of village Nagla Dhani, Rewari was found Corona Positive, and therefore, villages Nangla Ki Dhani, Mamaria Ahir, Mamaria Thetar & Mamaria Asampur, Rewari were declared containment zone on 16-05-2020, vide this office Endst. No. 16266-16365/COVID-19. According to the instructions received from the Directorate, corona test were done for 102 people coming in contact with the said patients and everyone has been tested negative and villages Nangla Ki, Mamaria Ahir, Mamaria Thetar & Mamaria Asampur, Rewari, door-to-door survey has been conducted in which no ILI and S.A.R.I patients have been detected.

Accordingly, following villages are eligible for scaling down, hence, de-notified as containment zone as per the provisions given in containment plan by Ministry of Health and Family Welfare Govt. of India and the aforesaid report of Civil Surgeon, Rewari. Now the containment zones are 53 in Rewari district as on 15-06-2020.
