De-containment Order, Dated 20-07-2020

The Civil Surgeon, Rewari informed vide his office memo No.DSO/RWR/COVID-19/2020/1022 dated 20-07-2020 that patients of villages/areas of District Rewari were found Corona Positive; therefore, villages/areas of District Rewari were declared containment zones. As per the instruction issued by Directorate of MoHFW Corona test was done of all persons came in contact with the said patients, and reported negative, besides door to door survey of the area was conducted and no ILI and S.A.R.I patients detected.

Accordingly, the following villages/areas are eligible for scaling down, hence, de-notified as containment zone as per the provisions of containment plan issued by Ministry of Health and Family Welfare Govt. of India and the aforesaid report of Civil Surgeon, Rewari.
