

ORDER

In exercise of the powers conferred under section 2 of the Epidemic Disease Act, 1897; the Department of Health and Family Welfare, Government of Haryana via notification No. 3PM(COVID)/2021/389-455, dated 25.03.2021 has directed all Deputy Commissioners of the State of Haryana to ensure that public celebrations & gatherings/ congregations during upcoming Holi festival shall not be allowed in public places/public grounds/public parks/markets/religious places etc. across the State.



To ensure compliance of above orders I, Yashendra Singh, IAS, District Magistrate, Rewari do hereby direct

- i. Superintendent of Police, Rewari to ensure that there are no gatherings/celebrations of the Holi festival in the public places as mentioned above.
- ii. All Incident Commanders along with police personnel deputed with them to keep surveillance in their respective areas.
- iii. All field level committees constituted via order 59692-768/COVID-19 dated 19-03-2021 to enforce COVID-19 related SOPs at public places.

Sub Divisional Magistrate, Rewari/ Bawal/ Kosli to supervise the enforcement of orders in their jurisdictions.

Any violation of this order will attract penal action under Section 51 to 60 of Disaster Management Act, 2005, under Section 188 of the IPC, 1860 and other applicable laws.

District Information and Public Relations Officer, Rewari is directed to ensure wide publicity for compliance of above orders in District Rewari.
