It is further informed that, you have to state the nature of your interest in the land and the amount and the particulars of your claims to compensation for such interest, your claim to Rehabilitation and Resettlement along with the objection if any to the measurement made u/s. 20.


It is further informed that your statement should be in writing and duly signed by you of your agent.
