Subject:- COVID-19 Containment measures- Implementation of lockdown measures.

Whereas, with the post-lockdown opening of the district, it has been noticed that there has been a considerable surge in the COVID-19 positive cases in the district and a potential threat of spread of infection through public transport, markets and social gatherings etc, restrictions were imposed in the whole district to arrest the spread of the virus;

Whereas, implementation of new guidelines on keeping asymptomatic +ve cases home quarantine is under way and systems are being put in place for its effective implementation'

Whereas, it has been noticed that there has been huge movement of general public in view of relaxation of restrictions for markets owing to festivals and there are apprehension of spread of virus which may get aggravated during the early stages of implementation of the new guidelines on Home quarantine of asymptomatic Covid +ve persons;

Whereas, restrictions on business establishments, public transports and public activities were imposed vide Order No.06/DMS of 2020 dated: 18.07.2020 from 18th July,2020 all further orders which was followed by order No.08/DMS of 2020 dated: 27.07.2020 with some relaxation of three days on eve of Eid ;

Whereas, it has been observed that some people are not adhering to the restrictions in place and are still moving around without wearing masks and violating the social distancing norms.

In view of the above and to control the spread of the infection, the restrictions already in placr are further intensified.


Therefore, I, Ch. Mohammed Yasin, IAS, District Magistrate, Shopian in exercise of the powers under Section 144 Cr.P.C and Section 34 of Disaster Management Act,2005 hereby impose the following restrictions from 04.08.2020 to 06.08.2020 With immediate effect:-

- 1) There shall be complete lockdown in whole of the district.
- 2) There shall be complete ban on movement/gathering of morethan three (03) persons anywhere in the district.

- 3) There shall be night curfew throughout the District from 09 PM to 06 AM.
- 4) All shops and business establishments shall remain closed in whole of the district.
- 5) There shall be complete restrictions on movement of both public & private transport except for goods/essential supplies vehicles and vehicles of Medical personnel and official dealing with COVID-19 containment measures with valid movement passes.

Sr. Superintendent of Police, Shopian shall implement the orders in letter and spirit.
