**Subject:- Restrictions in view of COVID-19 in District Shopian.**

**ORDER NO. 05/DMS of 2020**  
**DATED: 15 . 07 . 2020**

Whereas, a series of orders/communications stand issued by this office under the provisions of the Epidemic Diseases Act, 1987, the Disaster Management Act, 2005 and the Criminal Procedure Code to contain and check the spread of Corona virus (COVID-19), and;

Whereas, with the post-lockdown opening of the District, it has been noticed that there has been a considerable increase in the number of COVID positive cases , and a potential threat of spread of infection through public transport, markets and social gatherings etc;

Whereas, the District Administration was constrained to declare 63 villages as Red/Containment Zones, and a few cases have also been reported from the areas outside the containment zones, which clearly indicates the spread of the infection outside the Red/Containment Zones;

Therefore, in view of the above, and to contain the spread of infection and as a prophylactic measure, I, Ch. Mohammed Yasin, IAS, District Magistrate, Shopian in exercise of powers conferred under Section 144 C.R.PC and Section 34 of Disaster Management Act, hereby order that:-

- 1- All the shops and business establishments in the District shall remain closed **for a period of three days w.e.f 15<sup>th</sup> July 04:00 PM to 18<sup>th</sup> July, 2020.** The roster of rope rationalization of shops and business establishments notified by this office vide Order No.04/DMS of 2020 dated: 22.06.2020 shall also remain suspended during this period.
- 2- There shall be complete restriction on the movement of public transport in the district. Sr. Superintendent of Police, Shopian shall ensure the deployment of personnel at prominent Nakas to enforce the restriction of movement of all public transport and seize any vehicle found plying in contravention of this order. The personnel deployed at the Nakas shall also facilitate the movement of the following vehicles:-
  - a) Ambulances, patients, Medical emergency, travelers with valid air tickets.
  - b) Municipal Employees/Health Workers/Employees of Essential Services/ Government Employees working in the district proceeding towards their official duties, on production of valid departmental I-Cards.
  - c) Vehicles engaged by District Disaster Management Authority Shopian for COVID-19 containment measures.
  - d) Travelers/residents of the district arriving in the district by Air/ Road/ Rail.





- e) There shall be complete prohibition on all movement from Red/ Containment Zones, except for Medical emergencies and delivery of essential services to Red/Containment Zones. The concerned Tehsildars and Station House Officers shall be personally responsible for ensuring that directions issued vide various Orders issued by this office.
- 3- Concerned Tehsildars/Naib Tehsildars/BDOs/ZEOs shall ensure adherence to the SOPs regarding universal usage of face masks as notified by this office Order No.DMS/ADM-PS/20/2522-39 dated: 17.06.2020 .They shall also ensure strict adherence to the norms of social distancing.
- 4- The Administrators/Incharge Officers for supervision of Red/Containment Zones notified by various orders issued by this office shall personally monitor the Red Zones assigned, and shall remain in close liaison with the control room (01933-260825).
- 5- Concerned Tehsildars, Block Medical Officers, Station House Officers and Administrators of Red Zones shall ensure sampling of all vulnerable and immune-compromised people and service providers in Red/Containment Zones and of the vulnerable class/areas as notified in the Swasthya Nidhi data.
- 6- The livelihood activities viz works under MGNREGA, Self-Help Groups, Works being executed by the works departments(PDD, R&B, Jal Shakti Department, PMGSY,RDD) shall continue with strict adherence to SOPs on Social Distancing and Universal usage of Masks.

Sr. Superintendent of Police, Shopian shall ensure compliance of this order among public in letter and spirit.

**This order shall remain in force for a period of three days w.e.f 4:00 PM on 15.07.2020 to 4:00 PM on 18<sup>th</sup> July,2020.**
