
Executive Engineer, W.D. VI (Roads), P.W.D., Fatorda, Margao Goa, shall take the necessary steps for erection of Hump type speed breakers, strictly as per the specifications along with installation of necessary cautionary signboards and road markings of thermoplastic paint, fixing of cat eyes, as per IRC specifications laid down by the Ministry of Road Transport and Highways and as published in the official Gazette No. Series I No.15 dated 15th July 2005 by the Government of Goa and submit compliance report within 30 days. The Sign boards shall be installed as per specifications laid in the Seventh Schedule under the Goa Motor Vehicle (Amendment) Rules, 2005 & shall be located 50 meters in advance of the speed breaker and at the placement of the speed breaker.



Non compliance of Order, shall attract penal provisions u/s 188 of I.P.C., 1860.
