ORDER

UNDER SECTION 144 OF THE CODE OF CRIMINAL PROCEDURE OF 1973

WHEREAS, it has been brought to the notice of the undersigned by the Director and Ex-Officio, Joint Secretary (AH), Directorate of Animal Husbandry and Veterinary Services of Government of Goa that there is confirmation of Avian Influenza (H5N1) and (H5N8) outbreak in Poultry in Mahape Thane and Ghansoli Thane, District – Thane, Navapur – District Nandurbar of Maharashtra State;

AND WHEREAS, on perusal of the facts brought to light by the Director and Ex-Officio, Joint Secretary, Animal Husbandry & Veterinary Services, I am of the considered opinion that there is a serious risk to the health of the people in South Goa District if there is transportation and entry of live poultry birds and eggs from Maharashtra States;

NOW THEREFORE, I, Ruchika Katyal, IAS, District Magistrate, South Goa District, in exercise of the powers conferred upon me by Section 144 of the Code of Criminal Procedure 1973, do hereby prohibit transportation and entry of live poultry birds and eggs from the areas within the radius of 10 kms of infected zones of Mahape, Thane and Ghansoli Thane, District – Thane, Navapur – District Nandurbar of Maharashtra State into South Goa District, in addition to ban on transportation and entry of live poultry birds and eggs from the earlier areas within the radius of 10 kms of infected zones i.e. from Mumbai, Thane, Parbhani, Dapoli and Beed areas of Maharashtra State.

This order shall come into force **with immediate effect till further orders.**

As notice cannot be served individually on all concerned, the order is hereby passed ex-parte.

Any person contravening this Order shall be punishable under Section 188 of Indian Penal Code.
