



TERMS AND CONDITIONS GOVERNING THE APPOINTMENT OF DOCTORS ON CONTRACTUAL BASIS

The appointment of doctors on contract basis for working in CGHS Meerut shall be governed by the following terms and conditions:

1. The appointment is purely on contract basis for a period of one year or till the regular incumbent joins whichever is earlier with effect from the date of joining. Thereafter contract will lapse automatically. The appointment can be terminated at any time (on either side) by giving one month's notice or by paying one month's salary, without assigning any reason or on failure to complete the period of the three months to the satisfaction of the competent authority.
2. The consolidated remuneration mentioned is subject to revision at the instance of the Government.
3. The appointee shall perform the duties assigned to his/her. The competent authority reserves the right to assign any duty as and when required. No extra / Additional allowance will be given.
4. The Appointee shall not be entitled to any benefit life provident Fund, Pension, Gratuity, increment Medical attendance Treatment, Seniority, Promotion etc. or any other benefits available to the Government servants appointed on regular basis.
5. Non – Practicing allowance will not be admissible.
6. The appointee will not be granted any claim or right for regular appointment to any post under Central Health Service.
7. Only consolidated salary will be admissible. No dearness allowance and other allowance as are admissible to the Central Government Servants shall be admissible.
8. The appointee shall be on the whole time appointment of the institution and shall not accept any other appointment, paid or otherwise and shall not engage himself / herself in private practice of any kind during the period of contract.
9. The engaged Medical Specialist will be entitled for 2.5 days leave per month.


