
**ORDER**

Dated Dimapur the 21<sup>st</sup> March 2020

No. DEV-4/Medical/2017-D/10136-39A / In continuation to the various instructions, orders and advisories issued by the Government and in reference to the Chief Secretary letter No.CSO/GAB-CON-1/Gen-1/2020 dated 21<sup>st</sup> March 2020, and in exercise of the power conferred by the Regulation issued under section-2,3 and 4 of the Epidemic Disease Act 1897, Government of Nagaland as a measure to prevent and contain the spread of Novel Corona Virus (COVID-19), I hereby order :-

1. All shops located in:
  - a. Hong Kong Market, New Market, Hazi Park, Shangrila. Bata Charali (below flyover). Railway Bazar in Dimapur town
  - b. Central Market, Beituo Shuya Market, Medoze market complex and CRC market complex in Chumukedima are hereby directed to be closed with immediate effect till further order (except the shops and outlets dealing with vegetables, food grains and other food items and medicines).
2. All dine-in restaurants, dhabas and eateries in Dimapur district are hereby directed to be closed with immediate effect till further order, however any such outlets may keep its kitchen open if it plans on home deliveries or takeaways, provided all health safety measures are followed.
3. All malls, departmental stores, gyms, beauty parlours, salons/barber shops in Dimapur district are to be closed with immediate effect till further order.
4. Public are hereby restricted entry into any banks, financial institutions unless for extreme emergencies and essential activities (passing of Government bills and payments of user charges and fees, withdrawal of cash for urgent purposes and other such needs). All banks should adhere to the health advisories on prevention and spread of COVID-19.

This order comes into immediate effect. Any person, institution or organization found violating the order shall be deemed to have committed an offence under section 188 of Indian Penal Code 1860.
