**ORDER**

Dated Dimapur 2<sup>nd</sup> of April, 2020

Whereas, in exercise of the powers under Section 30(1)(2) under the Disaster Management Act, 2005 the undersigned issued a prohibitory order NO. DCD/COVID-19/2020 Dated Dimapur 31<sup>st</sup> of March, 2020 directing all shops, commercial and private establishments to remain closed for a period from 06:00 a.m, 1<sup>st</sup> April, 2020 till 12:00 midnight of 3<sup>rd</sup> April, 2020.

In continuation to the said order, to prevent and contain the spread of COVID-19, I Shri Anoop Khinchi, IAS, Deputy Commissioner, Dimapur hereby extend the prohibitory order directing all shops, commercial and private establishments to further remain closed from the midnight of 3<sup>rd</sup> April, 2020 to midnight of 5<sup>th</sup> April, 2020.

The above containment measures will remain in force in all parts of Dimapur District.

The order will however be exempted in respect of Police/Army/ Para-military forces/ Magistrate on duty/ Doctors and Medical staff including private hospitals & Clinics, medicine wholesalers & retail pharmacies, Bank staffs and persons engaged in emergency services.
