/In pursuance to the Gauhati High Court, Kohima Bench, Case No.PIL (Suo Moto)2/2019 regarding directives for blockage of traffic movement at Pagala Pahar area and in order to facilitate the progress of the four lane construction works and in the interest of public safety there will be total restriction of all movement from Chathe River Bridge (Patkai Bridge) to Kukidolong on the following days/time.

1. From 7 AM on 19th December till 5 AM on 21st December, 2020
2. From 7 AM on 9th January till 5 AM on 11th January, 2021
3. From 7 AM on 16th January till 5 AM on 18th January, 2021
4. From 7 AM on 23rd January till 5 AM on 25th January, 2021
5. From 7 AM on 30th January till 5 AM on 1st February, 2021
6. From 7 AM on 6th February till 5 AM on 8th February, 2021
7. From 7 AM on 13th February till 5AM on 15th February, 2021

The restriction is necessitated to facilitate speedy completion of works and as a precautionary measure to prevent any injury, loss of life and damage to property.

General public may take the alternative route from Dimapur - Kohima / Kohima - Dimapur for light vehicles only via 7th Mile - New D.C office - Shokhuvi - Razaphe- Mhaikam - Pimla - Mhainamtsi - Jhornapani/Medziphema and vice versa. All concerned may take note of the same for necessary action.


