Interested registered agencies/firms may submit their proposals within five days from the issuance of this notice in the office of Principal Census Officer (Deputy Commissioner) Kulgam alongwith relevant documents under the following terms & conditions:-.

Terms and conditions:

1. The agency/ firm should be registered with the government for providing IT consultancy/ manpower services.
2. The selected agency/ firm will be required to provide technical manpower for a period of 18 Months.
3. The agency/ firm shall not be allowed to transfer, assign, pledge or sub contract its rights and liabilities under this contract to any another agency or firm.
4. The requirement of District for the work of census 2021, is 26 Technical Assistants and 2 Multi-tasking staff. The details alongwith remuneration can be made available from the Office Principal Census Officer Kulgam.
5. The technical manpower to be appointed as Technical Assistants should have diploma/ degree in computer applications and manpower (MTS) should have matriculate qualification.
6. The agency/ firm will be required to complete the census assignment and will not be allowed to terminate the contract during the tenure.
7. The agency/ firm may submit their terms and conditions alongwith the letter of interest by or before 15^h March 2020 on their own, so that the firm/ agency is finalized by 16th March 2020.
8. Continuous performance (fortnightly) of the Technical Assistants is a must. Any laxity will lead to action under rules.
9. The engagement of this manpower will be purely on short term contractual basis. The hired manpower (Technical Assistants/MTS) will not be entitled to any claims, rights, interests, or further benefits in terms of regulations or consideration of further appointment to any post, including any claims for any casual, ad-hoc, Temporary, or regular service in the government.
10. Principal/ District Census Officer reserves the right to reject the interest of the agency/ firm if not satisfied with it.
