ORDER


Whereas, the threat of Coronavirus and its rapid transmission within the community requires immediate prevention and speedy remedy to prevent danger to human life and health and;

Whereas, various measures have been taken by the District for containment and management of this Epidemic disease as per the powers vested under relevant sections of IPC, Disaster Management Act, 2005 and the Epidemic Disease Act, 1897 from time to time.

Whereas, the situation has been reviewed afresh and in light of the observations and in reference to the order mentioned above, I Showkat Aijaz Bhat (KAS), District Magistrate Kulgam, by virtue of powers vested in me u/s 144 Cr.PC, do hereby order strict restrictions, to be imposed on movement of 4 or more individuals for all non essential activities between 7:00 PM to 7:00 AM till further orders. However medical exigencies are exempted. This prohibitory order is to be strictly followed/enforced. Any deviation shall attract penal action under Indian Penal Code (IPC)/Disaster Management Act, 2005.

Since it is not possible to serve this order individually it shall be circulated in the print, electronic and social media for information of all concerned.
