Subject:-Covid-19 Containment measures-implementation of lockdown measures.

ORDER

Whereas, restrictions were extended in the district vide this office No. DMK/PA/2020-21/1974-86 dated 03.08.2020 upto 6.08.2020.

Whereas, after assessing the situation regarding surge of COVID-19 positive cases and discussion with health authorities, it has been found that restrictions should be contained for time being to stop the spread of COVID-19.

Now, therefore, I, Showkat Aijaz Bhat (KAS) District Magistrate Kulgam, in exercise of the powers under Sec 144 CrPC, Section 34 of Disaster Management Act 2005 & Epidemic Disease Act 1897, the following restrictions are extended in the District from 07/08/2020 to 10/08/2020 with immediate effect:

- 1) That there shall be complete lockdown in the whole District.
- 2) There shall be night curfew throughout the District from 9:00 PM to 6:00 AM
- 3) All Shops and business establishments shall remain closed in both Urban & Rural areas.
- 4) There shall be complete restrictions on both inter and Intra-district movement of public transport including SUMOs, Taveersas, Auto Rikshaws etc. Only vehicle carrying goods, LPG, Oil Tankers, shall be allowed.
- 5) There shall be complete restrictions on both inter and intra-district movement of private vehicles including 2 wheelers. Only official vehicles and vehicles with valid permissions and those of Medical officials shall be allowed.
- 6) Concerned Tehsildars shall ensure the deployment of duty magistrates within their respective jurisdictions who, in collaboration with the Police Personnel and the officers authorized for imposing penalties for violating SOPs viz. staff of Traffic Police Kulgam, ARTO Kulgam, Health/FCS&CA, Municipal Committees and TSOs shall ensure adherence to the SOPs regarding universal usage of face masks as notified by this office order No. DMK/PA/2020-21/1837-60 Dated 21.07.2020 and penalize all violators.
- 7) That there shall be complete restriction on social and religious gatherings in the District.
- 8) Only Agriculture/Horticulture and construction activities works under MGNREGA, Self Help Groups, works being executed by different departments (KPDCL, PWD, RDD, PMGSY, Jal Shakti) shall be allowed as per SOP/DMRR guidelines.


