Reference :- District Health Society Kulgam's Advertisement Notice no. NHM/KGM/690-94 dated 11-01-2021 for the post of Nursing Tutor .

On the basis of overall merit calculated as per break-up of points on prorata basis as directed by Chairman District Health Society Kulgam, "In view of COVID-19 pandemic, interview to be not conducted. Let the selection criteria be purely based on merit as follows: -

1. B.Sc. (Nursing) = 90 Marks.
 2. Higher Qualification (M.Sc.) = 10 Marks.
- Total = 100."

and keeping in view the local criteria of medical jurisdiction of District Kulgam as per guidelines, the Merit List has been drawn as Annexure "A".


Accordingly keeping in view the no. of vacancies in pursuance to advertisement notice No.: NRHM/KGM/690-94, Dated: 11-01-2021, the Provisional Selection List along with Waiting List is drawn as Annexure "B".

The objections if any shall be received in the office of the Chief Medical Officer Kulgam within a period of 07 days after publication of notification in Print/ Electronic Media and thereafter no objection shall be entertained. The final selection list shall be operationalized after the stipulated time period.

Terms and conditions

1. The approval/Hiring of the candidates is purely provisional subject to the verification of original certificates and the institution where from they have passed the qualifying exams.
2. The Provisionally selected candidates shall have no claim for the monthly honorarium till the certificates are verified from the concerned competent authority.
3. The waiting list shall be operational for a period of six months.
4. In case of deficiency with reference to eligibility etc proved at any time of the Hiring process, the candidate shall forfeit his /her Hiring.
5. In case, at any time it is found that any candidate has used any fraudulent means/ certificate, his/her candidature /Hiring will be cancelled.
