2. Assistant Commissioner (Revenue), the Election Authority for the district, as notified vide SRO 475 of 1975 dated:30.09.1975 shall publish the electoral rolls as per above notified dates.
3. The Election Authority shall cause the list of voters of constituencies to be published by affixing copies thereof at his office and at Tehsil and Block Offices, calling claims and objections for inclusion / deletion / transposition / correction of names in the Electoral Rolls.


