Sub:-Declaration of Micro Containment Zone-regarding.

ORDER

Whereas, in view of emerging situation due to Covid-19, the State Executive Committee of Department of Disaster Management, Relief Rehabilitation and Reconstruction vide Govt. Order No. 11-JK(DMRRR) of 2021 dated: 30-03-2021, has empowered the District Magistrate to take local preventive measures for checking spurt in infections;

Whereas, the Chief Medical Officer, Doda vide his communication No. CMO/D/COVID-19/766 dated: 26-05-2021 and CMO/D/Covid-19/772 dated:- 27-05-2021 has recommended for declaration of Micro Containment Zone of village Dheraja of Tehsil Bhaderwah and village Joura Kalan Tehsil Thathri.

Whereas, it has been made to appear to me, in view of the situation emerging due to Covid-19 in two locations mentioned below in District Doda that there is sufficient ground for proceeding under Section 144 of CrPC for immediate prevention or speedy remedy desirable to prevent danger to human life, healthy and safety:-

Now, therefore, I, Vikas Sharma, KAS, District Magistrate, Doda, hereby order that the above mentioned one location shall be Micro Containment Zone and the following restrictions shall be in place with immediate effect and till further orders:-

- I. That the above mentioned areas shall be under strict lockdown and tight perimeter control, except for essential needs.
- II. There shall be no movement, whatsoever, in and out of the Micro Containment Zone.
- III. For any medical emergency, individuals can contact 24*7 Control Room at 01996-233337, 01996233465, 01996-233542 and necessary facilitation shall be done.
- IV. That it shall be mandatory for the person residing in designated Containment Zone to get themselves tested and any refusal in this regard shall invite action including filing of FIR under relevant provisions of Disaster Management Act. Magistrate and SHO concerned of the area shall ensure that 100 % sampling and testing is done.



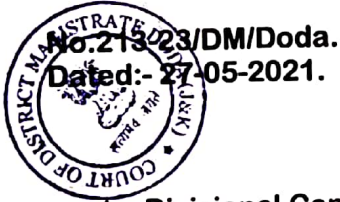

That it is further ordered :-

- I. That the Tehsildar concerned shall be overall incharge for enforcement of Micro Containment SOP in the notified zone.
- II. That the Chief Medical Officer, Doda shall ensure deployment of sufficient teams for sampling and surveillance of the designated zone. He shall ensure contact tracing of positives and their testing as per the SOPs.
- III. The District Control Room shall monitor strict home and medical isolation of all positives reported from the zone twice on daily basis.

Since, it is not possible to serve prior notice of this order, it is such being issued ex-parte. Any violation of this order shall invite punitive action under Section 188 of Indian Penal Code and other relevant Sections of Epidemic Diseases Act. 1897 and the Disaster Management Act 2005.

This order shall be widely circulated for information of all by the District Information Officer, Doda.
