**Sub:- De-notification of Micro-Containment Zones in District Doda –

ORDER

Whereas vide this office orders No:-191-201/DM / Doda dated:- 09-05-2021, 199-209/DM/Doda dated:11-05-2021, 223-33 / DM / Doda dated:- 15-05 -2021 245-57/DM / Doda dated:- 17-05-2021, 245-57/DM/Doda dated:- 17-05-2021, 213-233/DM/Doda dated:- 27-05-2021 Village Zartund of Panchayat Malan Dessa, Construction site of GMC Doda at Ghat, Village Berraru, Pasri Area of Bhaderwah Village Ghat near Madrassa, and Village Dheraja were declared as Micro Containment Zones; and

Whereas, Chief Medical Officer Doda and Incharge District COVID cell Doda vide office letter No:- CMO / D/Camp-DCoff / Covid/ 510-14 dated:- 28-05-2021, No.DCC/D/COVID/525 dated:- 13-06-2021 and DCC/D/COVID/530 dated:- 19-06-2021 has reported that medical teams were deployed for conducting daily testing with regard to Covid-19 at the designated Micro-Containment Zones as per the guidelines issued by State Executive Committee, Department of Disaster Management, Relief Rehabilitation & Reconstruction J&K vide Govt. Order NO:- 63-JK (DMRRR) of 2020 dated:- 24-06-2020 and after complete rounds of continuous sampling, no case of Covid-19 positive was found in the particular areas as reported by the concerned Block Medical Officers.

Now, therefore in view of the above facts the following Micro Containment Zones are hereby de-notified today on 19-06-2021 with immediate effect. All the restrictions/containment measures shall be withdrawn except latest unlock instruction/guidelines/SOP regarding containment measures, which shall remain enforced.
