2. Mi tumahin dawngdah takin eirawngbawlina thuk, meichhemna/tapchhak leh eirawngbawlina lam chi reng reng, entirna'n - thingtuah, meihawl, khawnvartui, thil kanna tel, meichher, gas, thingther etc. te kangmei tichhuak thei zawngin an chelek/hmang tur a ni lo.
3. Mi tumahin dawngdah leh inthlahdahna avangin an electric hrui zamdan/eng chhit dan, electric thuk etc. te meisi leh kangmei duhawm lo tichhuak thei zawngin an khawih danglam tur a ni lo.
4. Mi tumahin kawngsira thing phun/dingte a kan loh nan kawng an thlengin lo/huan an vat tur a ni lo.
5. Lo/Leipui vat tu ten mei lam tha takin an sial ngei ngei tur a ni.
6. March ni 15, 2020 hnu lamah tumahin lo/huan leh leipui an hal tur a ni lo.
