ORDER U/S 133 Cr PC

WHEREAS, information have been received that Cigarette, Tobacco, Sekhar tiranga, and like substances of abuse are sold illegally in grocery shops, nearby Schools and religious places of Namsai district.

WHEREAS, information has also been received that many grocery shops and hotels are selling Alcohol illegally in gross violation of trading license rules.

WHEREAS, it appears that the above said trade activity is injurious to health and posing danger to public health and safety.

WHEREAS, it is expedient to stop the illegal trade activity in the whole of the district of Namsai for public health and safety.

AND THEREFORE, I, Dr. Tapasya Raghav, IAS District Magistrate, Namsai District, Arunachal Pradesh, do hereby order:-

1. Complete ban on unauthorized sell of Cigarette, Tobacco, Sekhar tiranga and like substances of abuse in grocery shops, nearby Schools, Hospitals and religious places of Namsai district.
2. Complete ban on sale of illegal liquor in the grocery shops, nearby schools, Hospitals, religious places and hotels of Namsai District.

This order shall come into force with effect from the zero hour on 12.11.2018 until further order.

OC PS of the concerned Police stations, officials concerned form Market Committee and Superintendent of Tax and Excise will ensure enforcement of the ban strictly.


