ORDER U/S 144 Cr. PC

Dated Namsai, the 8th November 2018

Whereas it has been made to appear to me that a large number of commercial places/shops are using polythene/plastic bags including non-woven material of polypropylene 100% and Non-Biodegradable plastic bags in the area falling in the Namsai District, which is a big danger to the lives of human beings and animals.

Now therefore, I, Tapasya Raghav, IAS, District Magistrate, Namsai District, Arunachal Pradesh in exercise of powers vested under section 144 Cr. P.C. in compliance with the orders of the NGT hereby impose complete ban inter-alia use of plastic manufacturing, storing and/or any kind of plastic carry bag(s), Non-woven material of Polypropylene 100% and Non-Biodegradable plastic bag(s) in the area falling in the Namsai District.

No Person including a shopkeeper, vendor, wholesaler or retailer, trader, hawker or rehriwala etc., shall use a polythene/plastic carry bags for supply of goods in polythene/plastic carry bags including non-woven material of Poly Propylene 100% and Non-Biodegradable plastic bags(s) and further directs that no person shall manufacture, store, import, sell or transport polythene /plastic carry bags in the Namsai District.

This order shall come into force with effect from the zero hour on **09.11.2018** and shall be effective for a period of 60 days upto and including 08.01.2019.

In view of the emergent nature of the order, it is being issued ex-parte and addressed to the public in general.

This order shall be promulgated by announcement through publicity vans and by affixing copies thereof at the Notice Board of the Office of the District Magistrate, Namsai District and publication in the newspapers having circulation in the area.

OC PS of the concerned Police stations, officials concerned form Market Committee and District Medical Officer will ensure enforcement of the ban and submit weekly report in the matter.


