CIRCULAR

In view of COVID-19 pandemic, the Government has announced the benefit of free LPG cylinder refill for 3(three) months(April/2020 to June/2020) for existing beneficiaries of Pradhan Mantri Ujjwala Yojana (PMUY) as a part of relief under Pradhan Mantri Garib Kalyan Yojana(PMGKY).

Under this Scheme:-

1. Amount for refill of a LPG Cylinder (Retail Price) shall be credited to Bank accounts of existing PMUY beneficiaries by IOC limited.
2. Therefore, the PMUY beneficiary shall receive an SMS from the Oil Marketing Company(OMC) in her registered mobile number (RMN) to proceed to book the refill from the respective LPG outlet where her connection was issued.
3. Then, the beneficiaries can book the refill through IVRS/Mobile App/Whatsapp etc as applicable or if the customer or her family member doesn't have mobile number, she can submit a request in the prescribed form (Annexure-I) to the distributor to do counter booking which is available with distributor.
4. PMUY beneficiary shall ensure that their bank account and registered mobile number are operational. If not they can modify for "ONE TIME" only by filling and submitting form as per Annexure-II and IV of the scheme. Forms have been made available with LPG outlets.
5. There will be a time gap of 15 days between refill delivery and subsequent booking for customers with 14.2 kg connection.
6. The total numbers of PMUY beneficiaries under different LPG agencies in Namsai district are :-
 - A. M/S Chowmang Indane Service, Namsai- 2268
 - B. M/S Chowkham Gramin LPG Vitarak, Chowkham- 1336.
 - C. M/S Sanju Gramin LPG Vitarak, Mahadevpur-420.


