**PROHIBITORY ORDER
(U/S- 144 Cr.P.C.)**

Whereas, the Central and State government has been taking up all necessary measures for combating the spread of COVID-19 and whereas it is imperative to adopt social distancing and isolation measures across Namsai District for well being and safety of denizens.

And whereas, the Central Government vide Order No. 40-3/2020-DM-I(A) Dated 1st May' 2020 has extended lock down for a further period of two weeks with effect from 04.05.2020 and instructions issued by government of Arunachal Pradesh stipulating certain restrictions in the state of Arunachal Pradesh.

Now Therefore, I R.K.Sharma, District Magistrate, Namsai District, Namsai in exercise of powers under section 144 Cr.P.C. do hereby impose **curfew between 7 PM to 5 AM in entire Namsai District** with following terms & conditions with immediate effect till 17th May' 2020:

1. There shall be complete ban on movement of persons/any kind of vehicular traffic during the time period of curfew.
2. No shops or offices or institutions shall be open after 6 PM.
3. Movement of patients to/from Hospital/CHC/PHC/Sub-centre is exempted during the curfew.
4. Law and order/Fire & Emergency Services/Health services are exempted.

Violators of this order shall be viewed seriously and penal action will be taken as per law.
