ORDER

WHEREAS, the Central and State Government have been taking all necessary measures for combating the spread of COVID-19 and whereas it is imperative to adopt Social Distancing and isolation measures for safety of the denizens of Namsai District.

AND WHEREAS, with the detection of 28 (Twenty Eight) Nos. of COVID-19 positive cases and 02 (two) Nos. of COVID-19 positive cases among the returnees from other states in Changlang and Namsai Districts respectively, it is necessary to restrict the movements of public for containment of transmission of COVID-19 in the districts.

AND WHEREAS, I R.K.Sharma District Magistrate, Namsai District in exercise of power under Section 144 Cr.P.C. do hereby impose restriction on **Inter-district movement of persons and vehicles from Diyun, Miao & Bordumsa circles of Changlang District to Namsai District** except for medical emergencies and essential services with permission from concerned administrative officers.

Any violation or willful disobedience of this order will be liable for legal action under section 188 IPC

The Superintendent of Police, Namsai District and all the administrative officers-cum-Executive Magistrates, Namsai District are enjoined upon to implement this order in letter and spirit.
