**ORDER**

**WHEREAS**, few positive cases of Covid-19 have been detected in the district amongst the people put under home quarantine and also it has been brought to the notice of the undersigned that a person visited Mahadevpur Town and later on tested positive for COVID-19.

**AND WHEREAS**, contact tracing, quarantining and testing of all contacts/ suspects is being carried out by Health Department and few days of time is required for the results to be made available by ICMR-Dibrugarh (Assam).

**AND WHEREAS**, till the results are received or contact tracing and testing is completed, it is necessary to restrict the movement of people and vehicle in the district to prevent further spread of the disease.

**THEREFORE**, in exercise of the powers conferred upon me under DM Act, 2005 and in accordance with the guidelines issued by MHA, Govt of India Vide No- 40-3/2020-DM-I(A) Dtd 01/05/2020, I, R.K.Sharma Deputy Commissioner-cum-Chairman, District Disaster Management Authority (DDMA), Namsai do hereby impose the following restrictions **w.e.f. 2200 Hrs. of 15.07.2020 till 0500 Hrs of 23.07.2020 in entire Namsai District** with given Exceptions-

**RESTRICTIONS**

1. No movement of people including vehicles in this period within Namsai District, except for medical emergencies.
2. Except the following Government Offices, all other Government offices within the District shall remain closed.
  - I. District Administration, Planning, Food and Civil Supplies, Medical services, Veterinary clinics/hospitals Electrical, Water supply (PHED), Police, Armed Forces, Para-military, Municipal, Fire, Civil defence, Emergency services, Sanitation and Disaster Management Services.
  - II. For attending emergent works including Centrally Sponsored Schemes, officials in the District will be permitted to work with the prior approval of competent authority.
3. All commercial & Private Establishments shall remain closed except
  - i. Health Facilities, Diagnostic labs and Pharmacies.
  - ii. Telecommunications & internet services.
4. All transportation services will remain suspended.
5. All social/ political/ sports/ entertainment/ academic/ cultural/ religious functions/ gatherings shall be barred.
6. All places of worship shall be closed for public. No religious congregations will be permitted, without any exception.
7. Hospitality services will remain suspended except for establishments/ hotels used/earmarked for supply of food to quarantine facilities.

**EXCEPTIONS:**

1. All agricultural activities including Tea garden are permitted to operate ensuring social distancing.
2. Vehicles carrying tea-leaves outside district are allowed subject to thermal screening at Dirak Gate & certification to this effect by Health Department.
3. Home delivery of all essential food items including fish/ meat/vegetables & LPG Cylinders are allowed in between **10 AM to 4 PM** only.
4. Milk men/suppliers are allowed to regulate services.
5. Petrol Depots are allowed to operate.
6. In case of funerals, congregation of not more than 20 (twenty) persons will be permitted.
7. Personals and vehicles connected to management of quarantine centres are allowed.
8. Goods carrying vehicles moving to other districts via Namsai subject to the condition that such vehicles shall not stop in any place in the Namsai District.
9. Goods carrying vehicles (both essential and non-essential) into Namsai district subject to their thermal screening and certification at Dirak Gate.

**Any person violating these Lockdown measures will be liable to be prosecuted against as per the provisions of Section 51 to 60 of the DM Act, 2005, besides legal action under Sec. 188 of the IPC.**


