## ORDER

**WHEREAS**, as per Ministry of Home affairs Order No 40-3/2020-DM-I (A) Dated 29/6/2020 framed by Govt of India, the Deputy Commissioners are empowered to take effective measures for containment of the covid-19 pandemic.

**WHEREAS**, a case of Covid-19 has been detected in a person put under home quarantine at Manpaliang Village, under Lekang circle, Namsai district as per ICMR reports on samples collected on 8<sup>th</sup> July and reports received today on 13<sup>th</sup> July\*2020.

**WHEREAS**, there is every possibility of spread of the virus from the epicentre. It is felt necessary to immediately seal the geographical area of entire Manpaliang Village & Lenga gaon village to arrest the spread of COVID-19 in the interest of public health.

**THEREFORE**, the following schedule area is hereby put under "Containment Zone" with immediate effect-

**"Entire Manpaliang Village & Lenga Gaon village including all the peripheral entry & Exit points into the village".**

**In view of the sealing of the area as indicated above the following restrictions are hereby imposed U/S -30&34 of DM Act 2005.**

1. All kinds of vehicular movement is prohibited into and from the containment area.
2. No individual shall enter or come out from the containment area.
3. No shops / establishment shall open or function within the containment area.

**HOWEVER**, the movement of Health workers, police personnel, Magistrates, Medical emergencies and people authorized by the undersigned are exempted from the preview of above restrictions.

This order shall be implemented with immediate effect and will remain in force till further order.
