ORDER

In pursuance to Government Notification No. Secy.(Health)/SOP-11/2020/106 Dated 02.08.2020 effecting new SOP for better management of COVID-19 in the state, the following instruction is hereby issued with immediate effect:

1. Rapid Antigen Testing shall be carried out for all returnees as being done earlier. However, cost of Rapid Antigen Test shall be charged for labourers/construction workers being brought by various construction agencies. No charge on Rapid Antigen Test shall be applied to returnees.
2. The returnees may opt for Home Quarantine if tested Negative. The returnees and the guardian shall sign an undertaking that he/she will undergo strict 5 days home quarantine. The home shall be deemed to be under Quarantine and as such no persons shall come out or allow any person to visit the home during the period. A "Home under Quarantine" poster shall be pasted properly by the Health worker on such home under quarantine.
3. The District health authority shall ensure monitoring of health of the returnee put on Home Quarantine. A consolidated report of all people/returnee under Home Quarantine shall be furnished to the District Administration on daily basis at 6 PM without fail as per Annexure-I.
4. Returnees who do not have facility for Home Quarantine shall be put on Paid Quarantine at Wood peaker's Nest or Administrative Colony as per the vacancy at the moment. The rate shall be the prevailing rates notified vide No.-N/COVID-19 (Pt)/2020 dated 30.06.2020.
5. Health department may consider putting asymptomatic positive cases for certain category of people in home isolating if the criteria mentioned in Point No. 3 Notification No. Secy.(Health)/SOP-11/2020/106 Dated 02.08.2020 are fulfilled.
6. Free movement of people within the state is allowed without any restrictions except from and into the Containment zone.
7. Movement of people via Assam will be regulated by travel permit which will be issued at Check Gates with validity of 1(one) day only. Person staying beyond 1(one) day shall be dealt as per returnee protocol.
8. District Health Authority shall establish Rapid Antigen Testing centres in each DHC/CHC/PHC for Rapid Antigen Testing of people suspected to have developed COVID-19 like symptoms and shall be free of cost.

These regulations shall come into effect immediately for entire area of Namsai District and shall remain in force till further order or unless rescinded earlier.
