ORDER

WHEREAS, it has come to notice of the undersigned that denizens are engaged in bathing/diving in rivers and due to un-known accident prone areas, few instances of drowning has occurred in the rivers like **Noa-Dihing River and Jengthu River**.

AND WHEREAS, these accidents are alarming and calls for extreme caution not only by children but their parents as well as elders.

AND WHEREAS, it is felt necessary to immediately identify the mentioned below areas of Noa-Dihing River and Jengthu River as "Accident Prone Area" in the interest of public safety.

NOW THEREFORE, the schedule areas are hereby put under "**Accident Prone Area**" with immediate effect-

- "Coordinate -Latitude-27.637399 & Longitude-95.852034 (Upstream of Noa-Dihing River near Noa-Dihing Bridge)"
- "Coordinate -Latitude-27.675246 & Longitude-95.864237 (Downstream of Jengthu River near Jengthu Bridge)"

In view of the identification of the areas as "Accident Prone Area", the following restriction are hereby imposed as under -

1. All kinds of activities like bathing/diving/partying near the Accident prone areas is prohibited"
2. Entry of individual is prohibited in the Accident Prone Area.

Further, Parents, teachers and elders are advised to watch over children while bathing in rivers as they are very treacherous due to unpredictable weather.

The Executive Engineer, WRD Namsai is hereby directed to install "Accident Prone Area" Boards around the above mentioned areas at the earliest.

The Superintendent of Police, Namsai and Administrative Officers-cum-Executive Magistrates of Namsai District are hereby directed to enforce this order and action may be taken against violators as per various provisions of law.


