
**O R D E R**

**WHEREAS**, there is a surge in second wave of COVID-19 cases in the country and in neighbouring districts of Assam/Arunachal Pradesh. Consequently, it has become necessary to ensure strict adherence to SOPs and other regulations in order to contain the spread of Covid-19 pandemic in the district.

**THEREFORE**, in compliance to government notification No.Secy(Health)/SOP-11/2020 dated Itanagar the 17<sup>th</sup> April 2021, following regulations inter alia pertaining to meetings, marriages, funerals and other gatherings at public places or private premises in whole of Namsai District is enforced for strict compliance of all:

1. Permission for all public gatherings such as Marriage, festivals, religious ceremony, prayers and rituals, cultural gatherings and other celebrations in Namsai district should be sought from the district authorities **07(seven)** days prior to the commencement of marriage and other such celebrations. Such occasions shall be restricted to prescribed **attendance of 50(fifty) people only**, following all mandatory Covid Appropriate Behaviours (wearing of face masks, maintaining social distancing, avoid spitting in crowded public places and others).
2. Provisions for sanitizing and washing of hands should be installed at suitable place(s) within the premise/venue.
3. Information regarding death/funeral should be given to the District Authorities.

Violator(s) of this order shall be liable to be prosecuted as per provisions of Section 51 to 60 of the Disaster management Act, 2005 and will be punishable under Section 188 of Indian Penal Code.
