The intending tenderers should enclose / Bankers cheque in favour of The Deputy Director, Government General Hospital, Yanam for an amount of Rs.1000 (Rupees One thousand only) along with their tenders. The earnest money of unsuccessful tenderers will be refunded after the tender is over. The tender without earnest money will be summarily rejected.

4. The tender received after the due date and time will not be entertained.

5. The rate should quote for single who has quoted highest rate will be considered as successful bidder. If the highest rate quoted by the tenderer is not satisfied by the undersigned, open auction will conducted on the same day. In open auction, tenderers who have submitted sealed tenders will only be allowed.

The successful tenderer should pay the entire amount soon after completion of auction including G.S.T/sales tax as applicable under the rules in force and shift the e- waste unserviceable article immediately on same day before 5 p.m. from the premises of the Government General Hospital, Yanam at their own cost and risk, failing which the Deputy Director, Government General Hospital, Yanam shall not be the responsible for either safe custody loss or damage of the article once the tender is finalized.

7. No claim about the quantity and quality of the condemned article will be admitted once the tender is finalised.

8. The intending tenderers can inspect the condemned article during hospital working hours with prior permission of the concerned Head/Medical Officer in-charge of the GGH, Yanam.
