**OFFICE ORDER**

Whereas, the term of present Panchayat Raj (2013-2018) in the State has expired on 31<sup>st</sup> May, 2018 as per Notification on PR-ELECTION/478/2012 dated 30<sup>th</sup> May, 2018 which came into force with effect from 31<sup>st</sup> May, 2018.

Now, Therefore, in exercise of the power conferred under sub-section (7) of section 142 of the Arunachal Pradesh Panchayat Raj Act, 1997 (as amended by the Arunachal Pradesh Panchayat Raj (Amendment) Act, 2018) the Governor of Arunachal Pradesh is pleased to vest the functioning of Gram Panchayats to competent Authorities namely ***“Gram Panchayat Level Interim Committee”***.

In exercise of the power conferred to section 17 of the “The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement (Compensation, Rehabilitation and Resettlement, Development Plan) Rules 2015 and for the purpose of land acquisition of 50 Ha (Surface land= 47.7 Ha and River bed= 2.3 Ha) and 57.2 Ha (Surface land= 51.3 Ha and River bed=5.9 Ha) for the development of (186 MW) *Tato-I Hydro Electric Project* being developed by *M/s Siyota Hydro Power Private Limited (SHPPL)* and (240 MW) *Heo Hydro Electric Project* being developed by *M/s Heo Hydro Power Private Limited (HHPPL)* in Shi-Yomi District of Arunachal Pradesh is constituted with the following members:
