**NOTIFICATION UNDER SECTION 14 OF "THE RIGHT TO FAIR COMPENSATION AND
TRANSPARENCY IN LAND ACQUISITION, REHABILITATION AND RESETTLEMENT
ACT, 2013"**

1. Whereas, paragraph 1 of section 14 of "The Right to Fair Compensation and Transparency in Land acquisition, Rehabilitation and Resettlement Act, 2013" states that-

"where a preliminary notification under section 11 is not issued within twelve mont from the date of appraisal of the Social Impact Assessment report submitted by the Expert Group under section 7, then, such report shall be deemed to have lapsed and a fresh Social Impact Assessment shall be required to be undertaken prior to acquisition proceedings under section 11"


2. Whereas, "Multi-Disciplinary Expert Group" meeting was held in the office of Deputy Commissioner, Aalo on 28th March 2018 for the appraisal of SIA/SIMP prepared by RG University and the same has been recommended by the Expert Group.
3. Whereas, the validity of "Social Impact Assessment (SIA) studies report and Social Impact Management Plan (SIMP)" of (240 MW) Heo Hydro Electric Project is going to lapse by 27th March, 2019.

4. Whereas, the Deputy Commissioner, West Siang District, vide letter NO. LM/WS-3/VELCAN/559 dated 19th March, 2019 informed that Election Commission has declared for Parliamentary (LS)/AC election on 10th March 2019, accordingly the code of conduct was in force with effect from 11th March 2019 and therefore the Preliminary Notification under section 11 of "The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013" can-not be issued before 27th March, 2019. Further, the Deputy Commissioner requested the validity of SIA/SIMP report of (240 MW) Heo Hydro Electric Project being developed by M/s Heo Hydro Power Private Limited (HHPPL) to be extended for another 6 months in terms of the provisions of paragraph 2 and 3 of section 14 of "The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013" which states that –

"Provided that the appropriate Government, shall have the power to extend the period of twelve months, if in its opinion circumstances exist justifying the same;

Provided further that any such decision to extend the period shall be recorded in writing and the same shall be notified and uploaded on the website of the authority concerned."

5. Now therefore, in exercise of the powers vested under section 14 of "The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013", the Government of Arunachal Pradesh hereby extends the period of "Social Impact Assessment (SIA) studies report and Social Impact Management Plan (SIMP)" of (240 MW) Heo Hydro Electric Project being developed by M/s Heo Hydro Power Private Limited (HHPPL) in Shi-Yomi District of Arunachal Pradesh by another Six (6) months, i.e. by 26th September, 2019.
