Dated Aalo the 5th Sept' 2020.**CONTAINMENT NOTIFICATION**

Whereas, several positive cases of COVID-19 have been detected from various colonies/sectors under Aalo Township after two days rigorous RAT.

Whereas, more than five CV-19 positive cases have been detected in following colonies/sectors:

1. **New Market, Aalo/ Puak Gumin, Aalo/ Sipu Puyi, Aalo.**
2. **Cozy Resort/ Hungo Rigo Resort.**

Whereas, the contact tracing has to be expedited to check further spread of CV-19 in Aalo Township and its adjoining areas.

Therefore, I **Shri. Moki Loyi, District Magistrate cum Chairman DDMA** in the interest of public health do hereby notify above mentioned areas under **CONTAINMENT ZONE** with immediate effect. Further, following restrictions/ regulations have been enforced under the containment zone.

1. No entry/exit is permitted in the containment zone. Entry/ exit shall be barricaded/ cordoned off by police with the help of local committee.
2. The Home Quarantine persons shall not move out from their house/ room for a period of 14 days unless as permitted by the medical team under DMO/ DSO.
3. The movement of people for essential items and other emergency services shall be regulated by police along with identified local youths by concerned colony committee.
4. DF&CSO shall arrange to supply necessary essential items by following the Govt. SOP.
5. The DMO/ DSO shall detail medical team for monitoring the health status of quarantine inmates.
6. The concerned EM/SEM as capacity of Incident Commander shall carry out contract tracing as per SOP.
7. The DMO/ DSO shall carry out necessary Rapid Antigen Test (RAT).
8. EAC (TPT)/DDMO shall provide all logistic support as required.
9. DMO & EE, UD shall provide sanitization team for disinfection of containment area.

This order shall remain in force till declaration of de-containment by competent authority. Any violation of this order shall be prosecuted as per section 51 (b) of **Disaster Management Act, 2005** and under section 188 of IPC.
