Term and conditions of bid:-

(A) Technical Bid:-

1. Bid cost/Document fee submitted will not be refunded in any situation.
2. The EMD amount is interest free and all unsuccessful bidders will be refunded by the District Administration within 30 days of finalisation of contract. The EMD, for the amount mentioned above, of successful bidder would be returned upon submission of Performance Guarantee which will be 10% of total supply cost.
3. Agency should provide the AoA and MoA (in case of registered firm), By-laws and certificate of registration (in case of Pvt Ltd. and LLC) and Partnership Deed (in case of partnership deed) for proof of their legal entity.

4. Agency should provide copy of PAN, TAN and GST Registration certificate.
5. Agency should have average minimum turnover in the last 3 Financial years (i.e.: 2016-17, 2017-18 and 2018-19) of Rs. 1.4 crores.
6. Agency should provide the self-attested copy of ITR for last 3 Financial Years (i.e.: 2016-17, 2017-18 and 2018-19) along with audited books of account and audit report.
7. Agency must have at least 3 years of prior experience in supplying the items of this bid.
8. Agency must have prior experience of supply of goods of similar nature where the project amount is at least 50% of the supply cost of this bid. Bidders with supply experience to Govt entity/PSUs/ICDS will be given preference. For proof of supply, the agency should provide work order and invoice of the same.
9. The Agency should provide affidavit in original for non-engagement in fraudulent corrupt practice, non-blacklisting in any Govt. /PSU.
10. Any consortium or Joint Venture of bidders is not permissible. Bidders are required to respond to the RFP and participate in the bidding process as an individual entity.
11. The district administration reserves the right to cancel the bid or distribute the supply order to more than one bidder without expressing reason of the same.
12. The selected agency will be responsible for supplying materials directly to Anganwadi centres in consultation with the district administration.
13. A pre bid meeting will be arranged at the place of Bid submission on the above notified date. **IT IS MANDATORY FOR ALL THE BIDDERS TO ATTEND THIS MEETING.**
14. It is expected out of Bidders to bring a sample of the supply items at the time of pre bid meeting. Bidders can produce photos for the items for which it is not practically possible to bring the sample.

(B) Financial Bid:-

1. Bidder should quote only one rate for one item, otherwise the proposal will not be considered.
2. All rates quoted by the Bidder shall include GST. Administration will not bear the burden of any extra amount of GST, any other taxes or transportation charges etc. relating to the supply.
3. The list of materials to be supplied are provided as a part of this EOI in Annexure 1. Bidder must mention the brand they will supply in the financial proposal. Items with registered brand would be given priority over non branded items. Please write “**non- branded**” in case of non- registered brand.

(C) Other conditions:-

1. Any conditional bid will not be considered.
2. Bid of those bidders who have produced wrong papers and information, indulge in any fraudulent, blacklisted/debarred by any government agency will be rejected and legal action may be initiated.
3. No any extra amount will be given against escalation of price of supply items.
4. Bidder from Jharkhand would be given priority.
5. Decision of tender committee would be final considering the quality, quantity and rate of the supply items. Bidder must follow the term and conditions of the EOI.
6. The sealed envelope containing EMD, document fee, Technical Proposal and Financial Proposal should be put in single sealed envelope clearly marked “**Response to EOI for Supply of items for Creating Model Anganwadis (in 35 Anganwadis) under District Mineral Foundation Trust, Ramgarh**”- <RFP reference no.>and the wordings “**DO NOT OPEN BEFORE 3:00 PM on 14-09-2019**”.
7. The envelope thus prepared should also indicate clearly the name, address, telephone number, e-mail id and fax number of the bidder.
8. The rate at which this bid gets finalised will be used as the standard rate for all supplies in the future of these items.
