ORDER:

Whereas the Deputy Commissioner of the district is required to notify the circle rates in his jurisdiction every year but the State Government, Department of Revenue, vide notification No. Rev. Stamp (F)6-1/2009-III dated 22.01.2019 has constituted a committee for the rationalization of circle rates of land and rates of built up structures in the State and due to the Model Code of Conduct, this may take some more time to finalize its recommendations.

And whereas, the Addl. Chief Secretary (Revenue) to the Govt. of H.P. vide letter No. Rev.Stamp(F)6-1/2009-III dated 29.03.2019 has directed the Deputy Commissioners of the districts to notify the existing 2018-19 circle rates for the ensuing financial year 2019-20 uptil new rates are rationalized and finalized.

Therefore, in view of the Govt. instructions conveyed vide letter No. Rev. Stamp(F)6-1/2009-III dated 29.03.2019, I, hereby notify the circle rates of land and rates of built up structures for the financial year 2018-19 in respect of all the Tehsils and Sub-Tehsils of District Solan for the ensuing financial year 2019-20 uptil new rates are finalized.
