**CORRIGENDUM**

This Corrigendum is with reference to the Order issued by the undersigned under Section 144 of Cr.P.C., 1973, Revised-2, (CURFEW) bearing no. SLN/Reader/DM/1-14/89-IV-3828 dated 26.03.2020.

The relaxation in Curfew mentioned at Sr. No. 22 may be read as from **07:00 A.M to 01:00 P.M** in place of **08:00 A.M to 11:00 A.M** qua Shops or Stores selling groceries, milk, bread, fruits, vegetables, meat, fish, other uncooked food items and animal fodder. Liquor vends shall also remain open during the above period. In addition to this, exemption at Sr. No. 29 is added, which may be read as follows:

“29. The service of Social Justice & Empowerment (Welfare Office and District Programme Officer, ICDS) and their staff are exempted from the curfew.”

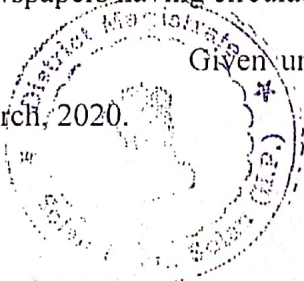
This order shall come into force w.e.f. 17:00 hrs on dated 26.03.2020.


In view of the emergent nature of this order, it is being issued ex-parte and addressed to the Public in general.

The compliance of these orders shall be ensured by the Executive Magistrates (including those especially appointed) and Police Officers/ officials. Violation may be strictly dealt with under relevant provision of the IPC.

This order shall be promulgated by the announcement through publicity vans and through press notes as well as social media for publication in the newspapers having circulation in the area.
