ORDER UNDER SECTION 144 Cr. P.C. (REVISED-4)

This Order is in continuation to this Office Order No. SLN/Reader/DM/1-14/89-IV- 3965 dated 3rd April, 2020 (Revised-3).

WHEREAS, the Additional Chief Secretary (Health) to the Government of Himachal Pradesh has directed all the District Magistrates in the State to take necessary measures for prevention of spread of the COVID-19, which has been already declared as pandemic by the World Health Organization, in their respective jurisdictions,


AND WHEREAS, the Health Authorities in the District Solun have freshly reported certain more symptomatic suspected cases of persons infected with COVID-19 in the Baddi Barotiwala Nalagarh (BBN) Area of Sub Division Nalagarh of District Solun, which is a matter of great concern and has necessitated the need of taking immediate strict steps for prevention of further spreading of this infectious disease,

THEREFORE, keeping in view the aforesaid facts and circumstances, I, K.C. Chaman, (IAS) District Magistrate, Solun (Himachal Pradesh) in exercise of the power vested in me under Section 144 of the Code of Criminal Procedure, do hereby order to **completely seal the following area of Nalagarh Sub-Division Nalagarh:-**


It is further ordered that under no circumstances ingress/egress of any person or vehicle, except officers/officials/vehicles on Government duty, to this area shall be allowed. Further, now there shall be no relaxation in CURFEW imposed qua any shops or Banks within the entire area as described above till further Order.

It is hereby clarified that Pharma and other Industries associated with production of essential commodity/unit shall function as usual, as well as movement of their worker(s)/employees in the permitted vehicle(s) shall also remain to be continued and transportation of essential commodities shall also remain uninterrupted in the above mentioned area. However, movement of workers/employees shall be allowed during the allotted time period only, i.e., **between 06:00 A.M to 08:00 A.M and 06:00 P.M to 08:00 P.M. Further, no worker/employee shall be allowed to commute on foot.**

This order shall come into force with immediate effect on dated 05.04.2020, till further orders.
