ADDENDUM


This is in continuation to this office Order No. SLN/Reader/DM/1-14/89-IV-4672 dated 3<sup>rd</sup> May 2020, vide which it has been ordered that the curfew relaxation hours will be between 09:00 AM to 02:00 PM and all shops/markets in M.C areas and Rural areas will remain closed on Sunday.

Now, keeping in view the interest and welfare of the general public, it is now hereby ordered that now New Curfew relaxation hours shall be from 08:00 AM to 03:00 PM, and all commercial activities/shops in Municipal areas shall remain allowed during the new curfew relaxation hours as previously ordered category wise on fixed days in the Municipal area (except shopping malls and shopping complexes), and in rural areas all shops (irrespective of its category) except those in shopping malls are allowed to open between new curfew relaxation period i.e. 08:00 AM to 03:00 PM from Monday to Saturday only. Further, all kinds of Chemist Shops, Pharmacies including Jan Aushdhi Kendras, Medical Laboratories, Private Hospitals & Clinics shall remain open between 08:00 AM to 05:00 PM on all weekdays. It is further, ordered that shops selling essential items shall also remain open on Sundays between 08:00 AM to 03:00 PM. All the Sabzi Mandies shall remain open between 05:00 AM to 03:00 PM on all week-days.

Further, it is ordered that now the Banks/ATMs correspondents, NBFCs, and Co-operative Credit Societies shall remain open between 10:00 AM to 04:00 PM.

NOTE:- Rest of the conditions shall remain unchanged.

This order shall come into force with immediate effect from 09.05.2020 onwards till further orders.


