**ORDER**

**WHEREAS**, it has come to the notice of the undersigned that due to detection of positive case of COVID-19, the area of Kalka Heights, Near Kalka Nursing Home, Opposite Bus Stand Kalka, District Panchkula has been notified as 'Containment Zones' by the District Administration of Panchkula (Haryana),

**AND WHEREAS**, the undersigned vide Office Order No. SLN/Reader/DM/1-14/89-IV- 5701 dated 24<sup>th</sup> May, 2020, has allowed Inter State movement of employees, workers, senior officers, promoters, traders, service providers, raw material suppliers and inspecting authorities of different Industrial Units, subject to compliance of Standard Operating Procedures (SOPs),

**AND WHEREAS**, the Ministry of Home Affairs, Government of India, has issued Guidelines vide Order No. 40-3/2020-DM-I(A) dated 30<sup>th</sup> May, 2020, as per which complete restriction has been imposed on the movement of people in or out of Containment Zones, except for medical emergencies and for maintaining supply of essential goods and services.

**NOW THEREFORE**, keeping in view the above mentioned facts and guidelines issued by the Ministry of Home Affairs, Government of India, I, K.C. Chaman, (IAS) District Magistrate, Solan (Himachal Pradesh), hereby orders that there shall remain complete restriction on Inter State movement of persons, including employees, workers, senior officers, promoters, traders, service providers, raw material suppliers and inspecting authorities of different Industrial Units, who are residing in Containment Zones as notified by the District Administration, Panchkula.

It is hereby clarified that Inter State movement of persons coming from outside the Containment Zones shall remain continue in accordance with this Office Order dated 24<sup>th</sup> May, 2020.

This Order shall come into force with immediate effect, till further Orders.
