ORDER

This Order is being issued in continuation to this Office Order No. SLN/Reader/DM/1-14/89-IV-7050 dated 24th June, 2020, vide which following areas was notified as "CONTAINMENT ZONE", (Ward No. 2 & 3, of MC Nalagarh area) viz; (1) House and Boutique of Covid-19 positive patient of Ward No. 3, Nalagarh, Tehsil, Nalagarh, (2) Road from PWD Rest House Entrance Gate to Guga Madi Chowk, Ward No. 2, Nalagarh, and (3) Road from Ropar Chowk to Guga Madi Chowk via Barfani Chowk, by the undersigned.


WHEREAS, the Sub Divisional Officer (C), Nalagarh, District Solán, vide letter No. NLG/SDM/PA/2020-3314 dated 29th June, 2020 has reported to the undersigned that contact tracing and sampling of all the direct/indirect contacts of above said COVID-19 positive cases have been done and as per report of BMO, Nalagarh, the CORONA test report in respect of all the direct/indirect contacts of COVID-19 positive cases of (Ward No. 2 & Ward No. 3) viz; (1) House and Boutique of Covid-19 positive patient of Ward No. 3, Nalagarh, Tehsil, Nalagarh, (2) Road from PWD Rest House Entrance Gate to Guga Madi Chowk, Ward No. 2, Nalagarh, and (3) Road from Ropar Chowk to Guga Madi Chowk via Barfani Chowk has been received as **Negative**. Therefore, de-notify the containment area due to that no new case COVID-19 found in the vicinity of above-mentioned areas, during the containment and such the containment of these areas are not required to be continued.

NOW THEREFORE, keeping in view the report of the Sub-Divisional Officer (C) Nalagarh, I, K.C. Chaman (IAS), District Magistrate, Solán (H.P) do hereby declares/de-notified that the areas of Containment Zone, i.e. (Ward No. 2 & 3 of MC Nalagarh area) viz; (1) House and Boutique of Covid-19 positive patient of Ward No. 3, Nalagarh, Tehsil, Nalagarh, (2) Road from PWD Rest House Entrance Gate to Guga Madi Chowk, Ward No. 2, Nalagarh, and (3) Road from Ropar Chowk to Guga Madi Chowk via Barfani Chowk, in Sub Division Nalagarh, now ceased to be containment zones. Hence, the restrictions imposed in these areas vide Order No. SLN/Reader/DM/1-14/89-IV-7050 dated 24th June, 2020, shall no longer remain in force. It is further ordered that the Order dated 1st June, 2020, issued by the undersigned shall remain continued to be applicable in these areas.
