ORDER

WHEREAS, the Executive Magistrate-cum-Assistant Commissioner (Protocol) Parwanoo, vide his Office letter No. **Asstt./((COVID-19)Part-II/2020- 3428 dated 13th July, 2020** has reported to the undersigned that one (1) CORONA positive case has been detected in Sector-2, Kasauli Road, Parwanoo, in Sub Division Solan, H.P.

AND WHEREAS, due to the above one (1) positive case of COVID-19, at Sector-2, Parwanoo. Therefore, there is an imminent danger of spread of COVID-19 in the adjoining areas/other parts of the area and to take strict measures to stop further spread of COVID-19, which if, not taken immediately, can pose grave danger to the lives, health and safety of the residents of area,

AND WHEREAS, in accordance with the guidelines of Ministry of Health and Family Welfare, Government of India vide Order No. 40-3/2020-DM-1(A) dated 01.05.2020, and in view the report of the Executive Magistrate-cum-Assistant Commissioner (Protocol) Parwanoo, the area falling in Sector-2, Parwanoo, Sub Division Solan H.P is required to be declared as "**CONTAINMENT ZONE**". Hence, strict prohibition upon the movement of people in the said containment zone, so that the risk to the lives of residents of these areas could be reduced.

THEREFORE, keeping in view the above mentioned facts as well as recommendation by the Executive Magistrate-cum-Assistant Commissioner (Protocol) Parwanoo, Sub Division Solan H.P, District Solan HP, I, K.C. Chaman, (IAS) District Magistrate, Solan (Himachal Pradesh) do hereby order to declare a "**CONTAINMENT ZONE**" as under:-

Panipat House and J.K. House with Shops at ground floor at Sector-2, Kasauli Road, Parwanoo to be fully ring fenced.

Further, keeping in view the aforesaid facts and circumstances and in exercise of the power vested in me under Section 144 of the Code of Criminal Procedure the undersigned orders that there will be complete restrictions on the movement of the peoples and vehicles (except the essential commodities) in the said containment zone.

It is further ordered that the various officer/official engaged with essential services shall maintain the supply of essential commodities to the said zone and further supply of drinking water, and electricity will be ensured uninterrupted to the containment zone. Further, the Chief Medical Officer, Solan will ensure to deploy sufficient nos. of teams for conducting door to door screening of person having SARI/Flu like symptoms throughout the

containment zone and will keep the regular surveillance and also trace all contacts (backward & forward) of all the COVID-19 positive cases and put them under isolation.

Further, it is also ordered that the Superintendent of Police, Solan will ensure to deploy sufficient Police force to restrict the entry and exit of person in the containment zone and also by way of the putting Naka to control the vehicular movements towards the aforesaid Containment Zone. No ingress-egress of any person, except officers/officials on law and order duty would be permitted in Containment Zone.

It is further, ordered that the Executive Magistrate-cum-Assistant Commissioner (Protocol) Parwanoo, will be overall incharge for the aforementioned containment zone and Tehsildar, Kasauli will assist him.

This order shall come into force with immediate effect for the above-mentioned areas and shall remain valid until completion of sampling of such areas and till all the samples are tested and reported negative.

NOTE: - Sanitization of all vehicles will be mandatory in containment zone during entry and exit, to be ensured by Assistant Commissioner (Protocol) Parwanoo.
